Kate Trammell, President, called the meeting to order.

Kate asked if there are any changes to the March minutes. Julie Hussey made a motion to approve the minutes from the March meeting. Weetie Whittemore seconded the motion. Full approval of minutes will come by proxy.

Linda Mallory, Treasurer, presented the budget for 2021-2022. (see attached) Linda asked that everyone get your expenses to her before the May picnic meeting. Linda thanked those that have already paid their dues. Weetie Whittemore moved that we approve the budget as it stands for 2020-21 with the corrections that were made. Barbara Williamson seconded the motion. Full approval of the Budget will come by proxy. Budget will be presented at the Membership meeting, Thursday April 8th.

Kate announced that there will be a joint meeting this year with the Memphis Garden Club. Memphis Garden Club is in charge of the planning of the meeting and LGC is in charge of the Joint Board Dinner the night prior to the meeting.
